The institutions<sup>1</sup> named below agree to cooperate for the exchange of students and/or staff in the context of the Erasmus+ programme. This agreement is valid for the Erasmus+ call years 20[24]-20[27] in:

- KA171

The institutions commit to sound and transparent management of funds allocated to them through Erasmus+ and to respect the quality requirements of the Programme, outlined in the Erasmus Charter for Higher Education<sup>2</sup> and in this agreement.

The institutions agree on exchanging their mobility-related data according to the principles of GDPR<sup>3</sup> and in line with the technical standards of the European Student Card Initiative<sup>4</sup>, when this becomes available for international mobility involving third countries not associated to the Programme.

Sending institutions located in EU/EEA countries have to ensure compliance with the provisions of art. 46 GDPR for all participants' personal data exchanged in the context of their mobility with institutions from non-EU/EEA countries without an adequacy decision, on the condition that enforceable data subject rights and effective legal remedies for data subjects are available in the respective third country. The participants should be informed in a transparent manner about the level of protection of their personal data, if this is different from the one where the sending institution is located.

- Ensure that outgoing mobile participants are well prepared for their activities abroad, including blended mobility, by undertaking activities to achieve the necessary level of **linguistic proficiency** and develop their **intercultural competences**.
- Provide assistance related to obtaining **visas**, when required, for incoming and outgoing mobile participants, according to the requirements of the Erasmus Charter for Higher Education and, if needed, use project funds in the most inclusive way to cover related costs partially or in full.
- Provide assistance related to obtaining **insurance**, when required, for incoming and outgoing mobile participants, according to the requirements of the Erasmus Charter for Higher Education and use project funds in the most inclusive way to cover related costs partially or in full. The receiving institution will inform mobile participants of cases in which insurance cover is not automatically provided.
- The receiving institution will inform about the existence of relevant infrastructure and provide support to incoming **participants with fewer opportunities**.
- Provide **appropriate mentoring and support arrangements** for mobile participants, including for those pursuing blended mobility, as well as **integrate incoming mobile participants** into the wider student community and in the Institution's everyday life.
- Provide participants with their **grant as soon as possible upon arrival**, including if necessary a first payment using cash, check or similar to avoid delays linked to opening a bank account.
- The institutions commit to encourage participants to act as **ambassadors of the Erasmus+ Programme** and share their mobility experience, e.g. by providing information about the existence of Erasmus+ alumni networks, inviting former participants in promotion activities, etc.

- Ensure that student and staff mobility for education or training purposes is based on a learning agreement for students and a mobility agreement for staff validated in advance between the sending and receiving institutions or non-academic organisations and the mobile participants.
- Accept all activities indicated in the learning agreement, or according to the learning outcomes of the modules completed abroad, as automatically counting towards the degree, provided these have been satisfactorily completed by the mobile student.
- Partners commit to taking measures to ensure recognition of student and staff mobility upon their return, including:
  - o Providing incoming mobile students and their sending institutions with free-of-charge transcripts. The documents must be in English or in the language of the sending institution and containing a full, accurate and timely record of the achievements at the end of the mobility period.
  - o A Transcript of Records will be issued by the receiving institution no later than [5] weeks after the assessment period has finished at the receiving HEI.
  - o Providing students on traineeships and staff with a certificate for the activities completed. It is recommended to issue a certificate towards the end of the mobility period.

It is recommended that receiving institutions provide the statistical distribution of grades or make the information available through [EGRACONS](#) according to the descriptions in the [ECTS users' guide](#)<sup>11</sup>. The table will facilitate the interpretation of each grade awarded to students and will facilitate the credit transfer by the sending institution.

### 1. Legal effect / Publication of the Agreement in the Czech Contracts Register

The contracting parties expressly stipulate that Charles University assumes responsibility for publication of this Agreement in the Contracts Register in line with Act No. 340/2015 Sb, as amended.

## **2. Protection of Personal data**

The contracting party from Erasmus+ Partner Country is obliged to create conditions for the protection of personal data of citizens of the Czech Republic in compliance with Czech law, and within the scope of, Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016, and to arrange for relevant technical measures to safeguard such data.

## **3. Mobility participants' insurance**

For the entire duration of the mobility period, participants must have adequate insurance coverage for medical expenses, liability insurance and/or accident insurance, especially if such insurance is required or recommended by the host institution. It is the responsibility of the sending institution of the participant to ensure that the participant is aware of health insurance issues.

## **10. Gender Violence**

The parties declare to know and accept the internal regulations on sexual harassment, violence and gender discrimination in the academic environment of the University of Chile, expressed, particularly, in the third paragraph of Article 9 of Law No. 21.369, which regulates Sexual Harassment, Violence and Gender Discrimination in Higher Education. In addition, the parties acknowledge that all relevant internal regulations and legal frameworks concerning sexual harassment, violence, and gender discrimination applicable under the laws and institutional policies of the European Union and Charles University must also be respected and complied with.

## **11. Termination of the agreement**

### **1. Withdrawal from the Agreement**

Either contracting party may withdraw from this Agreement without undue delay should the terms of the agreement be significantly violated. Such a withdrawal will take effect at the moment the other contracting party is formally notified. In such circumstances, all approved activities must be allowed to be completed.

### **2. Dispute settlement**

The Parties declare that this Agreement is based on good faith. In case of disagreement as to the interpretation and performance of this Agreement, the Parties shall endeavor to resolve it by mutual agreement, making their best efforts to reach an amicable solution to any dispute. Neither the European Commission nor the National Agencies can be held responsible in case of a conflict.
